## Terms and conditions

1. Entries accepted Mondays, June 23 and 30 from 3-7:30pm at Gallery 104. (address listed below) This is a juried show and not all entries will be accepted. Those not accepted will be notified and their entry fees returned.
2. Entry fees are as follows: \$25 for Arts Association of Oldham County members and \$50 for non-members. If you choose to join the AAOC upon entering the show, your entry fee will be waived. Memberships are available beginning at \$35.
3. Each artist can submit up to 2 pieces of work in their chosen medium.
4. All art must be display ready at time of submission.
5. You must bring your completed entry form listing title, size, medium and retail price of work with entry fee when you drop off your work.
6. A commission of 20% will be paid to Gallery 104 and 80% will be paid to the photographer within 30 days of close of show for any work sold during the exhibition at Gallery 104.
7. Art will remain on display from July 8 – August 5 with an opening reception July 11 from 6-8 pm
8. All art work must be picked up on Monday, August 4, 2008 between 3 and 7:30 p.m.
